Foreword of the President of the GNCHR

Human rights as universal and inalienable for every person, irrespective of race, colour, national or ethnic origin, descent, religious or other beliefs, disability or chronic illness, age, marital or social status, sexual orientation, or gender identity, are legally enshrined in a variety of binding or non-binding instruments at European, international and regional level. The internationalisation of human rights protection demonstrates that human rights stopped being an internal affair of the States and have now become a universal value.

Being aware of its responsibility as the National Human Rights Institution (NHRI), and in response to the mission assigned to it by the national legislator, as the independent advisory body to the State, the GNCHR collected and recorded some of the most important international human rights standards, binding or non-binding on the Greek State, which are presented in this list of international and European conventions on human rights, as a valuable tool of knowledge and information.

Introductory remarks

The Greek National Commission for Human Rights (GNCHR) is the National Human Rights Institution (NHRI). It was established by Law 2667/1998 in accordance with the Paris Principles of the United Nations and was first established on January 10, 2000. Its members are persons appointed by forty-two institutions whose activities cover the field of human rights (independent Authorities, universities, third level trade unions, NGOs, political parties and the Administration). In recognition, in particular, of the full harmonisation of the operation of the GNCHR with the international rules of minimum standards set by the Principles concerning the status of National Institutions (Paris Principles) and of its particularly important activity both at national and international level, the GNCHR has been accredited, since 2001, A status, which reflects the Country's international reputation.

According to the minimum standards set by the Paris Principles, NHRIs are entrusted *inter alia* with a very important responsibility to encourage the accession, ratification and implementation of international human rights treaties (Paris Principles, A.3 (c)). This is a fundamental function of the NHRIs, which is a – sometimes quite effective, though not always sufficient – pressure lever to improve the human rights situation in the Country.

In particular, to fulfill their mission, NHRIs must:

- monitor developments within international human rights law,
- encourage the participation of the State in the promotion and design of international human rights standards,
- evaluate compliance with and reporting on international obligations by national Authorities, through, for example, their participation in the Universal Periodic Review (UPR) process or the publication of annual and special reports,
- support the unconditional ratification of the treaties.


In order for NHRIs to carry out their mission effectively, it is necessary to systematically monitor not only the current legislation, but also any other legislative text introduced for voting, to ensure their compliance with human rights standards.

At the same time, in this context, NHRIs must inform State Authorities about the scope and nature of the obligations that the accession or ratification of international human rights treaties may entail for the State.

Being aware of its responsibility as an NHRI and in response to the mission entrusted to it by the national legislator, which consists *inter alia* of continuous monitoring of the development of human rights issues, promoting of relevant research, raising public awareness (Article 1(a), Law 2667/1998) and the organisation of a Documentation Centre on human rights (Article 1(6i), Law 2667/1998), the GNCHR collected international and European legally binding and non-binding texts on the protection of human rights and recorded them in a single list, always with the aim of ensuring the widest possible framework for the protection of human rights.

This list of Conventions, a useful tool in the hands of legal practitioners and scholars of law, is divided into five sub-thematic units, based on the Organisation within which they have been adopted (I. United Nations, II. UNESCO, III. International Labour Organization, IV. Council of Europe and V. European Union) and includes conventions which have not yet been signed or ratified by Greece.

For each convention, an active link is available on the official website of each organisation which includes the details of the convention. In case the convention has been ratified by Greece, a link to the ratification law is available (O.G.G. - National Printing Office).


